### 2. GENERAL POINTS

- I All emergencies shall be reported at telephone Nos. 9220410-9220411 and UAN No. 111-042-522 installed at Cantonment Board Lahore Office which shall be manned 24 hours.
- II The Cantt Engineer Mr. Pervaiz Iqbal, is deputed as Coordinator for all emergency teams. He shall report all matters and seek Guidance/instructions from the Addl:Cantt Executive Officer.
- III Addl: Cantt Executive Officer shall exercise full control and authority for implementation of emergency plan and all Cantonment Board staff shall be on call for performing such duties as he may direct.
- IV In addition to the separate groups as detailed below, a team comprising 10 malis and 02 Drivers shall be constituted by Addl: Cantt Executive Officer to be available in the Cantt: Board office at night from such date as he may decide.
- V For extra assistance in emergency, the Addl: Cantt Executive Officer shall keep a liaison with the D.D.O.R Cantt: who has been appointed as Relief Commissioner.
- VI Medical Team of Cantt: general Hospital shall be responsible for duty in both the Cantonments of Lahore & Walton.
- VII Addl: Cantt Executive Officer shall issue a duty roster of officials performing duty in complaint office 24 hours.
